FOUNDATION AT A GLANCE

- **Classroom Grants \$32,668** Provided grants for innovative programs and tools for teachers in the classroom.
- **Donor Designated Grants \$5,015** Coordinated donations made to donor designated schools or programs.
- **Elementary Enrichment Grants \$64,000** Collaborated with the Greater Albany Public Schools District, the Corvallis Arts Center, and Albany Parks & Recreation to award enrichment grants to 15 elementary schools.
- Scholarships \$44,250 Awarded 19 scholarships to graduating seniors at the district's three high schools.
- Sustainability Fund Additions \$134,555 Added significantly to this fund which helps insure that the Foundation can continue to operate as an organization to enrich and enhance educational opportunities for students, encourage teachers to implement innovative programs and award scholarships to graduating seniors.
